- The Reporting Person also owns the following securities: (i) 125,660 common units of limited partnership interest ("OP Units") in the Company's operating partnership subsidiary, Rexford Industrial Realty, L.P. (the "Operating Partnership"), of which 7,275 OP Units are held by the Schwimmer Living Trust dated December 14, 2001 (the "Living Trust") of which the Reporting Person is a trustee, and of which 42,002 OP Units are held by the Schwimmer Family Irrevocable Trust (the "Family Trust") of which the Reporting Person is a trustee, (ii) 751,019 LTIP Units, a class of limited partnership units in the Operating Partnership, (iii) 577,616 Performance Units, a class of limited partnership units in the Operating Partnership, and (iv) 13,575 indirectly owned shares of the Issuer's common stock ("Shares") which are held by the Family Trust of which the Reporting Person is a trustee.
