- 3. Represents OP Units of the Operating Partnership. The Issuer is the general partner of the Operating Partnership. OP Units are redeemable for cash equal to the then-current market value of one share of common stock of the Issuer, or at the election of the Issuer, for shares of the Issuer's common stock on a one-for-one basis.
- 4. The Reporting Person also owns 72,088 LTIP Units. LTIP Units are a class of limited partnership units of the Operating Partnership.
