OP Units are redeemable for cash equal to the then-current market value of one share of common stock, or at the election of the Issuer, for shares of the Issuer's common stock on a one-for-one basis.
- $2. \ The \ OP \ Units \ are \ exchangeable \ for \ common \ stock \ of \ the \ Issuer \ on \ a \ one-for-one \ basis.$

- 4. The Reporting Person also owns the following securities: (i) 593,508 LTIP Units, a class of limited partnership units in the Operating Partnership, (ii) 528,547 Performance Units, a class of limited partnership units in the Operating Partnership, and (iii) 64,248 shares of common stock, of which 13,575 shares are indirectly owned shares held by the Schwimmer Family Irrevocable Trust (the "Family Trust") of which the Reporting Person is a trustee. The Reporting Person disclaims beneficial ownership of the common stock held by the Family Trust, except to the extent of his pecuniary interest therein.
- 5. Represents 7,275 OP Units held by the Schwimmer Living Trust dated December 14, 2001, for which the Reporting Person is a trustee, and 42,002 OP Units held by the Family Trust, for which the Reporting Person is a trustee. The Reporting Person disclaims beneficial ownership of such OP Units, except to the extent of his pecuniary interest therein.
